

We Love THE OPEN (additional contest rules)

NO PURCHASE IS NECESSARY TO ENTER. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of the **US Open Swing Dance Championships, INC** herein known as THE OPEN as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting on June 23rd and will occur every Tuesday and Thursday until the Virtual weekend. Each contest will end 48 hours later.

4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided on **THE OPEN** Facebook page.
